

## Terms and Conditions

### Affin Education Financing-i “My Education, My Future” Campaign 2019

#### 1.0 Definition

1.1 The **Affin Education Financing-i “My Education, My Future” Campaign 2019** (“Campaign”) is organized by Affin Bank Berhad and Affin Islamic Bank Berhad (“the Bank”). The Campaign is subject to the respective Terms and Conditions set out herein. The following words and expression shall have the following meaning, unless the context otherwise requires:

- 1.1.1 **“AFFINBANK”** shall mean Affin Bank Berhad (25046-T)
- 1.1.2 **“AFFIN Islamic”** shall mean Affin Islamic Bank Berhad (709506-V)
- 1.1.3 **“Applicant(s)”** shall refer to Affin Education Financing-i applicants (Customer) during the entire Campaign Period.
- 1.1.4 **“Accepted Applications”** shall refer to duly signed and completed letter of offer pending disbursement by the Bank

#### 2.0 Campaign Period

2.1 This Campaign is valid from **1 August 2019 until 31 December 2019** both dates inclusive, or such other period(s) as may be determined by the Bank (“Campaign Period”) from time to time.

- 3.2.1 Affin Education Financing-i applicants who is in default of any payment and facilities granted by the Bank or account(s) have been suspended, blacklisted, cancelled or

terminated at any time during the Campaign Period, subject to the Bank's discretion, or

- 3.2.2 Applicant who has committed any fraudulent or wrongful acts in relation to his/her facility of service granted by the Bank

#### 4.0 Campaign Mechanics
